CALL TO ORDER:

Mayor

Mayor Lucas reported the following:

- Discussed concerns provided to Sound Transit from the Office of the Mayor and other concerned cities.
- Regarding the Western State escapees, a meeting is being held to discuss public alert procedures.
- An issue for the future, is how to increase mental health programs statewide and how these needs will be funded.
- Gave us a Puget Sound Regional Council update.
- Shared that Steilacoom's Farmers' Market was featured in The Puget Sound Fresh local farm guide. The first Steilacoom market is June 1st.
- West Pierce Fire and Rescue has their complete annual plan available.

Administrator

Town Administrator Loveless reported the following:

- The AWC conference is June 21-23 in Everett this year.
- The next Council meeting will be a training session. It will include open public meeting training. Commission members will also be present for this training.
- Sound Transit will be given taxing authority if Sound Transit 3 passes. Discussed what considerations need to be addressed.
- The Farmers' Market starts June 1. We are expecting a robust market this year thanks to a new energetic coordinator. June 29th is the first Summer Concert.
- Regarding lead in the water, Steilacoom has no lead gooseneck connections. Staff tests the Town water system frequently along with the schools.

Attorney

Attorney Hoffman reported the following:

- No new litigation.
- Recently attended the Washington State Municipal Attorney conference. He shared what was discussed and added that Steilacoom is obviously well managed by Council and staff compared to other jurisdictions.

Public Safety

West Pierce Assistant Fire Chief Tinsley reported the following:

- In regards to the two escapees at Western State, there have been meetings to discuss how they secure their windows at this establishment. They are securing the windows from the outside now.
- Reported that Steilacoom School District has started warning notifications via texting.
- West Pierce has been busy with a few small fires including arson cases. Arrests have been made.
- Five recruits are graduating this Friday.
- Reported that they have two new medic units, one fire engine currently being built and one new battalion chief rig.

Public Works

Public Works Director Burlingame reported the following:

- A preconstruction meeting will take place regarding the Sentinel Way street project now that the agenda bill has been approved.
- There have been requests for tree trimming and tree cutting in two areas in Town.
- Our vactor truck is down in Oregon for repairs. Staff will pick it up tomorrow.
- A public meeting was held to discuss the Lexington Street improvements with residents that will be most impacted.
- Spring Clean-up was held in which 653 vehicles participated in two days.
- Happy to report that Cherrydale Park is now open.
- Summer hires have been interviewed and selected. The first person will start next week.
- The grant application for Steilacoom Boulevard thru the Tunnel of Trees was submitted. We will see if we are successful.
- Shared a Directive from the Governor memo regarding drinking water. These involved potential regulations for the future.

 Reported that he participated with spring clean-up this year. He helped with e-cycling and the Goodwill donations.

Councilmember Franklin reported the following:

 On Sunday he helped participate with interviewing students from Steilacoom High School for college scholarships. He stated that there were some outstanding candidates.
