Other information that was covered was shared. The Kiwanis Club is taking on the project of reroofing the gazebo at the Sunnyside Beach picnic area. Town staff has been very helpful in facilitating with this project. Councilmember Franklin had no comment. **Councilmember Henderson** reported the following: • Welcomed Judy Bittenbender to the Planning Commission. She thanked her for her service. Residents' blocking public parking is irritating. It confuses the public and would like to see it eliminated. She shared an unfortunate event that occurred in her neighborhood recently.
