REPORTS: Mayor **Public Works Director Burlingame** delivered the staff report and answered questions from the Council.

Councilmember Franklin moved and **Councilmember Neal** seconded to approve Change Order #7 to ACI Inc., authorizing the replacement of 3 monuments and casings (adjusted to the new finish grade) for an additional cost of \$13,440.00, thereby increasing the total contract (not to exceed) amount payable to \$3,042,959.94 and authorizing the Mayor to sign the necessary documents on behalf of the Town of Steilacoom.

Public Works Director Burlingame delivered the staff report and answered questions from the Council.

Councilmember Smith moved and **Councilmember Crumley** seconded to approve Supplemental Agreement #1 to Gray & Osborne Inc. for additional construction management services in the amount of \$44,905.00, increasing the total (not to exceed) amount payable to Gray & Osborne to \$409,950.00.

Town Administrator Loveless delivered the staff report and answered questions from the Council.

Councilmember Henderson moved and **Councilmember Smith** seconded to modify the Personnel Regulations updating the Regulations related to Family Medical Leave, Military Family Leave, and Paid Family Medical Leave – Section 1.43.

Mayor Lucas reported the following:

- The Mayor attended an in-district meeting today with Pierce County Council, at the Thornwood Castle, to discuss the issue of car tabs.
- Commented that the Mayor of DuPont, Mike Courts, will be leaving office soon. He worked tirelessly on economic development. He is moving on to become a local ski instructor.
- Discussed the Mobile Community Intervention & Response Team program. They have had many successes during the first year.
- The Mayor recently attended the Transportation Improvement Board meeting. He discussed issues on past & future projects.
- Shared what to expect during the upcoming state audit exit.
- The Mayor commented that the Steilacoom High School Leadership class includes a sharp group of kids.
- Discussed 5-G improvements for the future.
- Shared the history on a small tree in front of the Public Safety office.
- The Mayor and acting Chief Yabe attended the Police Academy today. He shared what was observed during the training.
- The next Mayors' Forum topic is the discussion of affordable housing.
