AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Town operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Town of Steilacoom from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Utility cash receipting, account adjustments, and write off process
- General disbursements
- Fuel cards
- Credit cards – home improvement stores
- Safeguarding of small and attractive assets such as gas powered equipment

INFORMATION ABOUT THE TOWN

The Town of Steilacoom was incorporated in 1854 and currently serves approximately 6,410 Pierce County citizens.

An elected, five-member Council and a separately elected Mayor govern the Town. The Mayor appoints an Administrator to oversee the Town's operations as well as its 49 full- and part-time employees. The Town operates under a two-year budget of approximately \$39 million, including a \$10.5 million general fund budget for 2017-18. It provide services including police, parks and recreation, community development, and utilities (electric, water, sewer and storm drainage). In 2012 the Town started to contract for fire and medical services and in 2013 contracted for Municipal Court services.
