## APPENDIX C

### PARKING REGULATIONS (pursuant to Res. 763 as amended)

1. **Prohibited parking.** No person shall park any vehicle or allow any vehicle owned by him to be parked upon any of the following places at any time:

**Birch St.** No parking in the hammerhead turn-around at the end of Birch Street. (Ord. 1580 §2, 2018).

**Chambers Bay Court.** No parking on the east and south sides from Chambers Bay Drive to the cul-de-sac. (Res. 1040 §1, 2005; Res. 1037 §1, 2005).

**Chambers Point Court.** No parking on the east and south sides from Chambers Bay Drive to the cul-de-sac. (Res. 1040 §1, 2005; Res. 1037 §1, 2005).

**Chambers Bay Drive.** Northeast and southwest sides from Chambers Creek Road to Chambers Point Court. ((Res. 1040 §1, 2005; Res. 1037 §1, 2005; Res. 878 §1, 1993; Res. 816 §1, 1990).

**Chambers Creek Road.** From the intersection of the southwest corner of Cedar Street extended north to the Town limits, except in those portions of the street so marked for a limited amount of parking time.

**Commercial Street.**

(1) On the north side of Commercial Street between Main Street and 90 feet east of Chambers Street except on the northwesterly side between Wilkes and Main Streets in two designated parking spaces with parking limited to no more than one-half hour.

(2) South side, from Union Avenue twenty-two feet east.

(3) South side from Chambers Street to Wilkes Street, except for designated areas for leased parking.

**First Street.** West side, from Champion Street to 165' south of Montgomery Street. (Res. 896 §1, 1994).

**Frederick Street.** Either side, from Lafayette Street to Union Avenue.

**Lafayette Street.**

(1) East or west side, from the intersection of the southwest corner of Cedar Street extended north to the Town limits, except in those portions of the street so marked for a limited amount of parking time.

(2) North side, between Union Avenue and centerline of Chambers Street.

(3) South side, from Union to Pacific Street.

**Pierce Street.** East side, between Commercial Street and the alley to the south.

**Rainier Street.**

(1) Northwest side, from Puyallup Street to Union Avenue.

(2) Southwest side, 120 feet northeast of Union Avenue to Union Avenue.

(Res. 1029 §1, 2004).

**Union Avenue.**

- (1) East side, between Sequash Street and the north side of Lafayette Street.
- (2) West side, between Lafayette Street and Gove Street, and adjacent to Lot 6, Block 7, Chapman's Part of Steilacoom.
- (3) West side, between its intersection with Lafayette Street and the Steilacoom dock.

**Western Road.** Both sides, from its intersection with Chambers Creek Road to its terminus.

**Wilkes Street.**

- (1) East side, between Lafayette Street and Commercial Street
  - (2) Both sides between Lafayette Street and Rainier Street.
- (Res. 1038 §1, 2005; Res. 767 §1, 1987; Res. 763 §1, 1987).

**2. Two Hour Parking.** No person shall stop or park any vehicle for longer than two hours at any one time along the following portions of streets:

- (1) 2nd Street from Martin Street to Champion Street.
- (2) 3rd Street from Martin Street to Gove Street.
- (3) 4th Street from Martin Street to Champion Street.
- (4) 5th Street from Martin Street to Gove Street.
- (5) 6th Street from Martin Street to Jefferson Street.
- (6) 7th Street from Champion Street to Jefferson Street
- (7) From June 1, 2015 through June 30, 2015, on any street or road within Town that is not signed otherwise.

(Ord. 1526 §7, 2015; Res. 1044 §1, 2005).

**Chambers Street.**

- (1) From Commercial Street to Lafayette Street.
- (2) South side, from Sequash Street to Nisqually Street (10:00 p.m. to 6:00 a.m. only)

**Commercial Street.**

(1) North side, in the spaces provided, from its intersection with Chambers Street, 90 feet east.

- (2) South side, thirty feet from Union Avenue to Chambers Street
  - (3) North and south sides, from Main Street to Puyallup Street
- (Res. 1071 §1, 2007; Res. 1038 §2, 2005).

**Champion Street.**

- (1) From 2nd Street to 4th Street.
- (2) From 5th Street to Union Avenue.

**Frederick Street.** From Rainier Street to Sequash Street.

**Gove Street.** From 3rd Street to Union Avenue.

**Lafayette Street.**

- (1) North side, from Frederick Street to Main Street.
- (2) South side, from Pierce Street to Main Street.
- (3) From 6th Street to Union Avenue.



**Main Street.**

(1) East and west sides, from Lafayette Street north to the alley between Lafayette and Commercial Streets.

(2) From Commercial Street to Rainier Street.

**Martin Street.** From 6th Street to Union Avenue.

**Montgomery Street.**

(1) From 3rd Street to 4th Street.

(2) From 5th Street to Union Avenue.

**Nisqually Street.**

(1) From Frederick Street to Main Street.

(2) East side, from Chambers Street to Pacific Street (10:00 p.m. to 6:00 a.m. only)

**Pacific Street.** From Lafayette Street to Nisqually Street.

**Pierce Street.**

(1) West side, between Commercial Street and the alley to the south.

(2) From Rainier Street to Starling Street.

**Rainier Street.** South side, from Union Avenue to Puyallup Street.

**Sequalish Street.**

(1) West side, from Braecrest Street to Chambers Street (10:00 p.m. to 6:00 a.m. only)

(2) East side, from Braecrest Street to Chambers Street (10:00 p.m. to 6:00 a.m. only)

**Starling Street.** From Union Street to Puyallup Street.

**Steilacoom Street.** From Rainier Street to Nisqually Street.

**Union Avenue.**

(1) East side, in the spaces provided for parallel parking between its intersections with Rainier and Lafayette Streets.

(2) East side, in the spaces provided for angle parking between its intersections with Lafayette and Commercial Streets.

(Res. 1049 §1, 2005; Res. 1038 §2, 2005; Res. 1020 §1, 2003; Res. 889 §1, 1994; Res. 843 §1, 1992; Res. 830 §1, 1991; Res. 767 §2, 1987; Res. 763 §2, 1987).

**3. Four Hour Parking.** Repealed by Res. 843 §2, 1992.

No person shall stop or park any vehicle for longer than four hours at any one time along the following portions of streets:

**Commercial Street.**

South side from Main Street to Wilkes Street.

**Wilkes Street.**

1. West side, from Commercial Street to Rainier Street

2. East side, from Lafayette Street to Rainier Street.

(Res. 1038 §3, 2005).

**4. Parallel Parking.** No person shall stand or park a vehicle within the right-of-way and on the west side of Union Avenue, north of its intersection with Lafayette Street other than parallel with the edge of the roadway. (Res. 763 §4, 1987).

**5. Perpendicular Parking.** Perpendicular parking will be allowed on the west side of Wilkes Street between Commercial and Lafayette Streets. (Res. 763 §5, 1987).

**6. Handicapped Parking.**

(a) The Director of Public Works shall designate and post on the east side of Union Avenue in close proximity to the Steilacoom Dock and on the west side of First Street in close proximity to the overpass one parking space for use by handicapped persons whose vehicles display special license plates or decals issued pursuant to RCW 46.16.380, or pursuant to companion statutes of other states. No person shall park any vehicle at any time within the designated space, except vehicles displaying the special license plates or decals. (Res. 896 §2, 1994: Res. 763 §6, 1994).

(b) Any vehicle displaying a legally issued, disabled parking placard may be parked for a period of time not to exceed four hours:

(1) Wherever on-street, nonreserved parking is legally permitted within the Town of Steilacoom, or

(2) In any on-street parking space reserved for physically disabled persons. (Res. 961 §1, 1998).

**7. Ferry Lane Parking.**

(a) Ferry traffic storage lanes are hereby established on the west side of Union Avenue between Rainier Street and the Northern Pacific Railroad right-of-way. All traffic waiting for loading shall do so only in such area as designated on Union Avenue. Ferry storage is prohibited in any other location.

(b) No automobiles shall stop or stand in the traveled part of the roadway between Rainier Street and the Northern Pacific Railroad right-of-way.

(c) The Director of Public Works is directed to post adequate directional or other informational signs to effectuate the plan and purpose of this section. (Res. 763 §7, 1987).

**8. Loading Zones.**

**Commercial Street.** Thirty minute loading zone in the space designated twenty-two feet east of Union Avenue. (Res. 767 §3, 1987).

**9. Parking Restricted.** No person shall park any vehicle or allow any vehicle owned by him to be parked upon any of the following places during the designated times:

(a) Both sides of **Galloway Street** between C Street and D Street from 7:00 AM to 5:00 PM. Monday through Friday. (Ord. 1508, 2013)

**2. Sign Permit Fees.** The fee for a sign permit as provided by SMC 14.20.010 is set at \$30.00.

**3. Copying Fees:** Copying fees shall be as follows:

- Public records \$0.15 per copy
- Motor vehicle accident reports 5.00 each (victims will not be charged)

**4. Special Service Fees:**

**5. Radon Detector Fees.**

(a) Until the earlier occurring of the termination of the program requiring the provision of radon detectors as currently mandated by State law or amendment or repeal of this section, the building official shall collect ten dollars (\$10.00) from the owner or applicant or his, her, or its agent, to reimburse the municipality for the costs incurred in the acquisition, maintenance, and distribution of the radon detector.

(b) The building official shall provide to the individual to whom the radon detector is delivered, the appropriate information in relation to the responsibility of the individual for the return of the detector to the appropriate testing laboratory.

(c) This section shall be deemed confirmatory of action previously taken by the building official and, to the extent that any such reimbursement fees have already been collected, it shall be deemed ratification of such action.

**6. Boat Launch Parking Lot Fees.** The following fee schedule is adopted for use of the boat launch ramp and underpass beneath the Burlington Northern tracks in the vicinity of the terminus of Union Avenue, and the related off street parking lot maintained by the Town and described in SMC 10.64.200(2a).

- (1) For parking, per day, of any motor vehicle in the parking lot, six dollars.
- (2) For parking, per day, of any boat trailer and its tow vehicle in the parking lot, six (\$6.00) dollars.
- (3) For a monthly parking pass, seventy-five dollars.

(Res. 1077§1, 2008:Res, 1028 §1(part), 2004: Res. 989 §1(part), 2000: Res. 979 §1(part), 1999).

**7. Sunnyside Beach Parking Lots.** There is imposed for the privilege of parking any vehicle for each day or any portion thereof in any parking lot maintained by the Town abutting Chambers Creek Road, in the vicinity of Sunnyside Beach, the following charges:

- Steilacoom residents No fee with parking permit
- Nonresidents \$ 5.00
- Monthly parking pass \$75.00

## APPENDIX E

### SPEED LIMITS

(Pursuant to Resolution No. 890 as amended)

**1. Twenty miles per hour.**

No person shall drive a vehicle in excess of twenty miles per hour when:

(1) Passing any schoolhouse or adjacent school playground from 8:00 a.m. to 10 a.m. and 2:00 p.m. to 4:00 p.m. Monday through Friday;

(2) Crossing any marked school crossing 8:00 a.m. to 10 a.m. and 2:00 pm to 4:00 p.m. Monday through Friday. (Res. 1141, 2016; Res. 1086 (part), 2009; Res. 1025 §1, 2004; Res. 958 §1, 1998; Res. 917 §1, 1995).

**2. Twenty-five miles per hour.** Except as authorized by Section 3 of this Appendix, no person shall drive a vehicle in excess of twenty-five miles per hour on any public street or highway, or portion thereof, within the Steilacoom corporate limits. (Res. 1086 (part), 2009).

**3. Thirty miles per hour.** No person shall drive a vehicle in excess of thirty miles per hour on the following portions of the following arterial streets:

(1) Steilacoom Boulevard, from the corporate limits to the intersection of Steilacoom Boulevard and Puyallup Street;

(2) Union Avenue, from the corporate limits to the intersection of Union Avenue and Powell Street;

(3) Chambers Creek Road, from a point beginning four hundred feet north of the intersection of Chambers Creek Road and Western Road, northward to the Town limits. (Res. 1096 (part), 2009; Res. 1086 (part), 2009).

**APPENDIX F**  
**SCHOOL ZONES**

**1. Purpose.** The purpose of this resolution is to establish loading zones, setting speed limit signs, and authorizing the placement of school zone signs and speed limit signs in the area of Cherrydale Elementary, Saltar's Point Elementary and Steilacoom High School. (Res. 1083 §1, 2009: Res. 916 §1, 1995).

**2. Loading zone signs.** The public works department of the Town of Steilacoom is authorized to erect and maintain loading zone signs at the following locations:

(A) Steilacoom High School:

- (1) Southeast corner to parking lot
- (2) Northwest corner by the gym

(B) Pioneer Middle School: East side of Chambers Street between Nisqually and Sequash

(C) Saltar's Point Elementary: North side, front of building

(D) Cherrydale Elementary: East side of Galloway between "B" and "D" Streets  
(Res. 1083 §1, 2009: Res. 916 §2, 1995).

**3. Speed limits.** The public works department of the Town of Steilacoom is authorized to erect and maintain speed limit at the following locations:

(A) Steilacoom High School:

(1) East side Sentinel Drive within 100 feet of Steilacoom Boulevard facing south.

(2) North end of Sentinel Drive within 50 feet of Western State/McNeil Parking lot gate on west facing north.

(B) Saltar's Point Elementary: Third Street

(C) Cherrydale Elementary:

(1) On Stevens Street between Shepard and "B" Streets

(2) On Old Military Road between Natalie Lane and "D" Street

(3) "B", "C", "D" Streets within 25' of Old Military Road, on right side of roadway
